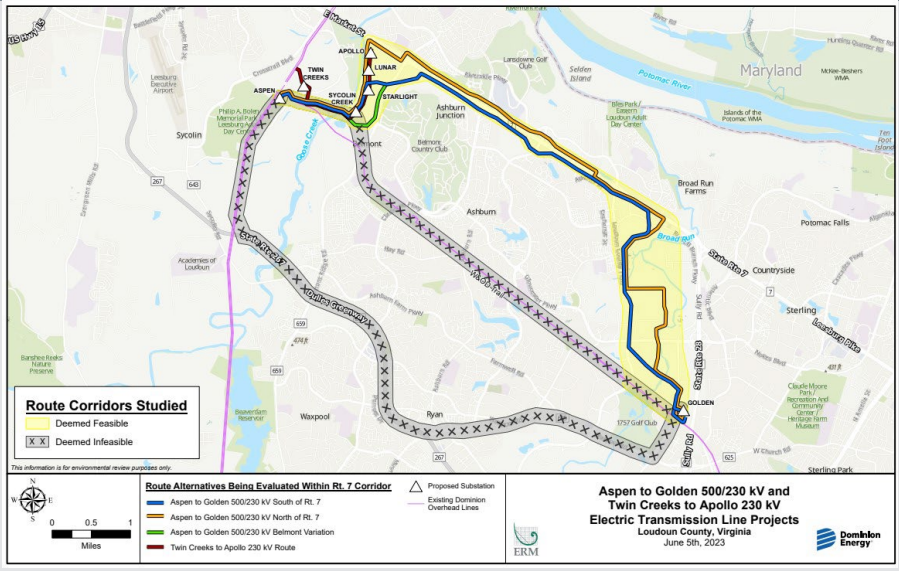
Algonkian Pkwy Feasibility Study Kick-Off



I was thrilled to join the Department of Transportation and Capital Infrastructure (DTCI), representatives of Kimley-Horn, and a broad stakeholder group of county staff to kick-off the Algonkian Parkway Feasibility Study this week! This project will bring together many stakeholders in county government and the community to review the existing conditions of the Algonkian Parkway corridor and the current trails. My goal is to assess the feasibility of constructing continuous multi-use paths that cover the entire length of the parkway.

This study will take place over the course of the next year, with anticipated final recommendations and report coming in Spring 2024. It is my hope that this study produces realistic and beneficial recommendations to implement my office's vision of a multimodal corridor in which all pedestrians and cyclists can easily travel for recreation, exercise, and commuting.

Dominion Energy Transmission Line Project

Dominion Energy is moving forward with a project to construct high-capacity transmission lines across Loudoun County. Over the last month, Dominion Energy has sent postcards by mail to Loudoun residents with information about the proposed project. Because of energy needs in the area, Dominion is planning to connect two new substations. The route currently being reviewed be either on the north or south side of Route 7 (see map above).

I continue to have concerns regarding above-ground transmission lines along Route 7 and will continue to express opposition to any plans that bring these transmission lines to the Algonkian District.

Dominion is hosting an in-person community meeting at Broad Run High School on Thursday, June 29, 2023 from 5-8pm. I encourage all residents with input, concerns, or questions to attend that meeting and make their voice heard.
