## Approved Whitfield Place Parking Restrictions

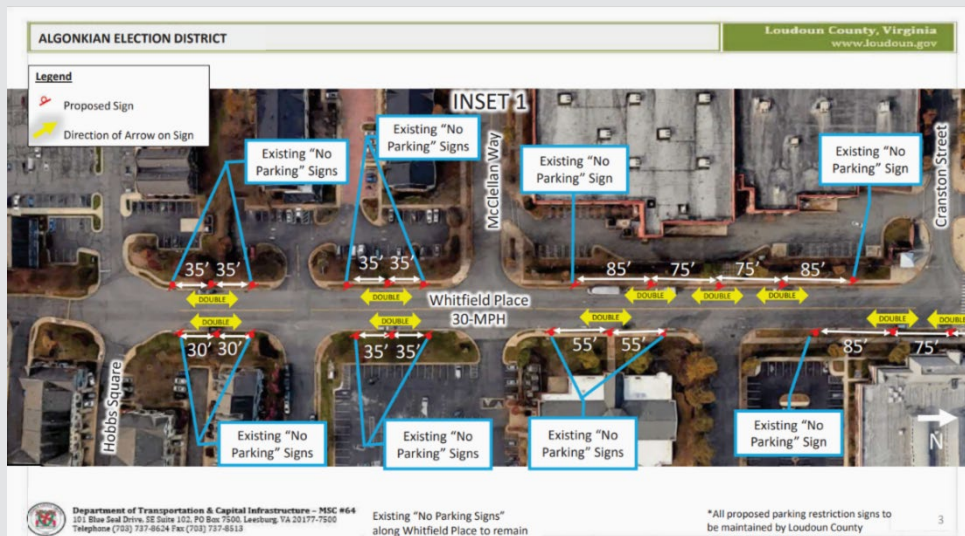
The Board of Supervisors voted unanimously to approve new parking restrictions to prohibit overnight parking between the hours of 8pm and 7am. I have heard numerous complaints from residents and patrons of the Cascades Marketplace, Senior Center, and Library about the long-term parking of large trucks, commercial vehicles, tractor trailers, and boats. Since last year, I have worked with county staff to assess our options and identify a solution to this problem. As a result of that work, staff brought this item to the Board for approval.



Based on an assessment of the street through a site visit with DTCl and conversations with transportation staff at the county and state level, it was determined that an overnight parking restriction was the best option. It would still allow for daytime parking and use of the street for patrons of the library, senior center, and surrounding Cascades Marketplace businesses but would prohibit any long-term parking of vehicles along Whitfield Place.

The item authorized funding for the purchase and installation of the signs. My office will keep residents informed of when the signs will be installed and when the new policy is in place.

## Zoning Ordinance Rewrite Public Hearing

### Planning Commission Completes Draft Zoning Ordinance Review



The Loudoun County Board of Supervisors is hosting a Public Hearing for the Zoning Ordinance Rewrite next week on Wednesday, July 26th at 6pm in the Board Room at the Government Center (1 Harrison St. SE, Leesburg, VA). County staff will present on the current draft Zoning Ordinance that was recommended for approval by the Planning Commission. Afterwards, Board Members will be afforded the opportunity to make brief comments and then it will be open to the public.

The purpose of the hearing is to take public comment on the draft Zoning Ordinance as the Board moves forward with an extensive set of work sessions this

Fall. I invite all residents who have input and ideas for the draft Zoning Ordinance to share your perspectives at this meeting!

## Loudoun Youth Services Center

Loudoun County is offering new support services at the Youth Services Center in Leesburg, which now includes the new Youth and Family Resource Center, the new RISE Youth Shelter, and the now re-located Juvenile Detention Center. The Youth and Family Resource Center provides services to youth age 11-17 who face behavioral challenges - including issues at home, in the community, and with peers - with Loudoun County programs and services to support their development. The RISE Shelter supports court-involved youth in a safe, structured, and supportive environment. The Loudoun County Juvenile Detention Center (JDC) now operates from the new Youth Services Center building. The JDC is a secure facility that provides youth detention as ordered by the Juvenile and Domestic Relations Court.

Loudoun County is offering grants to help businesses financially impacted by the renaming of several streets and roads in Loudoun County. The county's Road Renaming Business Assistance Program is open to for-profit and nonprofit businesses with an address on a roadway being renamed at the direction of the Board of Supervisors following the Board's decision to inventory and review Confederate and segregationist symbols in the county. The program includes a one-time grant and a sign reimbursement grant and is being administered in two phases, based on location. The application process will close December 1, 2023.
