## Summer Wellness Fest



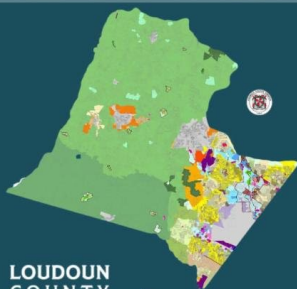

## Zoning Ordinance Rewrite Process

### Planning Commission Completes Draft Zoning Ordinance Review



The Planning Commission has forwarded the Draft Zoning Ordinance to the Board of Supervisors.

The Loudoun County Board of Supervisors hosted a Public Hearing last week to take comments on the Zoning Ordinance Rewrite. The Loudoun County Zoning Ordinance is a formal document that regulates how land can be used across Loudoun County as well as sets policies for all types of development.

The current draft was recommended for approval by the Planning Commission after a lengthy process with many work sessions. The BOS heard from many concerned citizens and stakeholders regarding the draft ordinance and will be taking their comments into consideration when reviewing the document. Next, the Board of Supervisors will begin an extensive process to review the new Zoning Ordinance draft and make any needed changes before voting on it later this year. The BOS will host a series of work sessions to review specific chapters of the ordinances. All meetings will take place at 6pm in the Board Room of the Government Center. The approved schedule is as follows:

- Thursday, September 7: Introduction and Zoning Districts.
- Monday, September 11: Uses in the Urban, Suburban, Office, and Industrial Zoning Districts.
- Monday, September 25: Uses in Rural, Transition, and JLMA Zoning Districts.
- Monday, October 2: Overlay Districts and Natural and Environmental Resources.
- Thursday, October 12: Development Standards.
- Monday, October 16: Signs.
- Monday, October 23: Attainable Housing.
- Monday, October 30: Procedures, Officials, Boards, and Commissions, and Flexible Regulations.
- Wednesday, December 13: Public Hearing

## Vehicle Tax Relief for the Elderly & Disabled First-Time Applications

Those who are 65 & older or permanently & totally disabled & who meet income & net worth requirements are eligible for a reduced tax rate on one vehicle per qualified applicant.

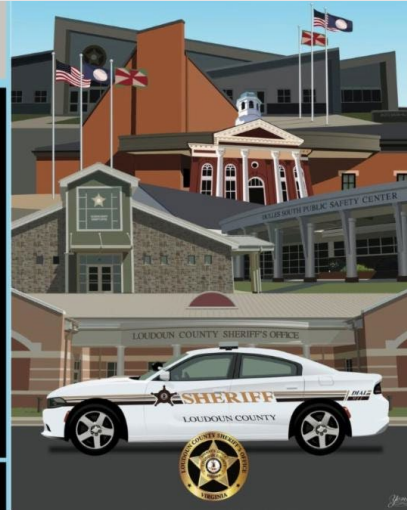
