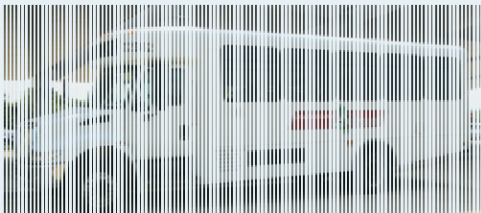


Passenger Courtesies
